_____ I will let my provider know PRIOR to arrival to my home or services provided at one of the agreed upon locations if anyone in the household is experiencing any of the above symptoms or has had a known direct exposure to COVID-19 within the last 14 days.

In these uncertain times , I wanted to reach out to everyone about what we are doing here at Just Us Swim Kids to support you and your swim needs. As the situation around COVID-19 continues to evolve, we are doing everything we can to ensure your safety as well as the safety of your child and provide maximum care.

Your Safety

As it has always been, the safety and security of our JU family and team members remains our highest priority. We take great pride in maintaining the highest standards of cleanliness and hygiene. In response to the coronavirus, we have taken additional measures developed in consultation with global and local public health authorities (including the WWA AND CDC) to make our cleaning and hygiene protocols even more rigorous to minimize the risk of infection from social interaction. We expect all of our members to adhere to all guidelines.

We will continue social distancing in and out of the pool. No group lessons will be provided unless there is adequate space or the students occupy the same household.

- To minimize contamination students will no longer share equipment. Each child will have their own supplies that will be purchased from your instructor at the start of lessons.
- If you exhibit or experience symptoms of COVID-19; had contact with someone who has received a positive test result for COVID-19 or is otherwise suspected to be infected with COVID-19 or have traveled to high risk area in the preceding 14 days you should not come to the pool.
- The instructor will wear a face shield. Please note there will be times the instructor will not wear a shield due to demonstrations of underwater work.
- Parents **must** wear a mask in the facility and on the pool deck.
- More sanitizing stations will be available for your use.
- Please note there will be time needed in between sessions to allow sanitizing of our work area.

- There will be seating on the pool deck but will be limited to one parent at a time. There will also be sanitizing equipment to wipe chairs **before and after use.**
- Your temperature may be taken at the front desk to be sure there is no fever present. If you suspect you have been in contact with a person or persons that have contracted the coronavirus please notify your instructor and do not head to the pool.
- Pool times have also been adjusted we will be allowed to start we will be instructors will be allowed to teach from 10-4

We know this will be an adjustment but we do appreciate your help in keeping everyone in and around the pool safe. will be adding new protocol as we run into things that may come up. If you have any concerns please let us know we want your feedback. We need every JU swim members to comply with the rules and promptly report any violations to your instructor.
